1 | CALL TO ORDER, NATIONAL ANTHEM AND WELCOME

Chair Dennis called the meeting to order at 12:02 p.m. and O Canada was led by students from Fish Creek School by way of a pre-recorded video.

Chair Dennis acknowledged the traditional territories and oral practices of the Blackfoot Nations, which includes the Siksika, the Piikani, and the Kainai. She also acknowledged the Tsuut'ina and Stoney Nakoda First Nations, the Métis Nation (Region 3), and all people who make their homes in the Treaty 7 region of Southern Alberta.

The Chair welcomed trustees and superintendents participating in the Board of Trustees' first virtual public Board meeting. She also welcomed everyone joining on the livestream, and thanked staff for their work to support the Board in making the virtual meeting possible.

Chair Dennis provided the following statement:

"Firstly, I would like to acknowledge these are unprecedented times. The Board hopes that all our students, parents and staff are healthy and safe. We would also like to recognize the outstanding commitment of all CBE staff in their support of student



learning in the face of the COVID-19 pandemic. We look forward to the day students are able to attend classes once again at CBE schools.

On Saturday, March 28, the government announced \$128 million in education funding reductions and directed school boards to reduce staffing levels for educational assistants, substitute teachers, other support staff and bus drivers.

This announcement came as a surprise to us. We were disappointed that as the democratically elected board of trustees we were not consulted on this decision or given the opportunity to share the vital work that many of these CBE staff have been doing in support of our learning plan for students. Although in-school classes have been cancelled, schools remain open and learning must continue. Staff are working hard to connect with students and their families to identify needs and create resources to support students in this challenging new environment. In addition, staff are also working to ensure that schools are safe and clean for the staff that are still working in our schools and in preparation for the eventual return of students.

On Tuesday, March 31, the CBE was informed that our funding would be reduced by \$21 million. We are doing as much as possible to minimize the impact of this in-year funding cut on staff and students, but layoffs will be necessary in order to balance our budget. As a school board we cannot have an unfunded deficit at the end of the year.

Although we do not know when in-school classes will resume, we are looking ahead to the 2020-21 school year. According to the school jurisdiction profiles released by Alberta Education in February 2020, the total funding to the CBE is expected to increase by \$13.5 million for next year. However, CBE's final funding for 2020-21 will not be confirmed by Alberta Education until the end of April.

For 2020-21 enrolment growth is forecast to be approximately 2,300 students, or the equivalent of four large elementary schools. With increased enrolment and a new funding model, this will mean a reduction in per-student funding. This reduction in per-student funding will have an impact. We continue to review how to best deliver programs and services within the funding we receive. Our first priority is always to support students and their learning."

3 | CHIEF SUPERINTENDENT'S REMARKS

Chief Superintendent Usih provided remarks about the Alberta Government's announcement on March 15 respective of the global pandemic and cancellation of classes. He noted that adapting to a new reality of working and delivering learning remotely to CBE's 125,000 students is a monumental task. Since March 15 system-based staff have been working tirelessly to get students and teachers prepared for ongoing learning. For many CBE students, classes resumed last week following spring break – for modified calendar schools, classes resumed April 6. Chief Usih noted that students are now engaged in learning in different ways, demonstrating resilience, flexibility and compassion.

Chief Superintendent Usih expressed appreciation to families for their support to student learning while juggling work and other responsibilities. He also thanked teachers who are checking in with students regarding not just their learning, but also about how they are feeling, and connecting families to supports including technology, mental health, food and other community resources; and support staff in schools and central offices, including facility operators and service unit teams for continued support of the work in schools.
