



## Area 6 and 7 Impacted Schools Engagement Proposed Plan

### Group A: Rosscarrock School, West Springs School, Wildwood School

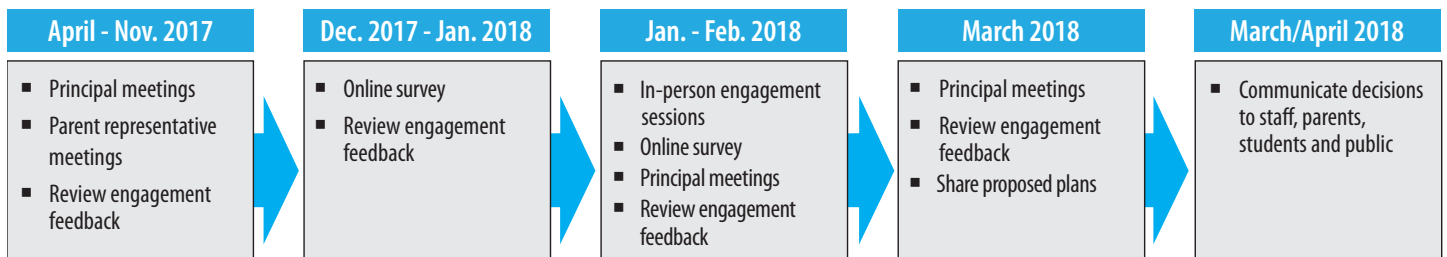
The opening of many new schools over the last few years has resulted in changes for thousands of Calgary Board of Education (CBE) students. With more students attending school closer to home, space has become available in the schools they previously attended. The CBE is working with stakeholders to determine how space can be utilized to most effectively meet the learning needs of students across our system. Engagement for schools impacted by new school openings began in February 2016. The period between June 2016 and March 2017 focused on engagement with affected school communities in other CBE areas.

Given the later timing of some school openings in Areas 6 and 7, conversations with principals and parents about which schools would be included in a 2017-18 community engagement process began in the spring of 2017. These discussions were focused on schools that might be directly or indirectly affected by the openings of Dr. Roberta Bondar School, Griffith Woods School and West Ridge School. Eight schools were originally identified to be involved. In reviewing the input and feedback and then developing plans, it was determined there would be no changes for two of these schools, Glenbrook School and West Ridge School. The six remaining schools are:

**Group A:** Rosscarrock School, West Springs School, Wildwood School

**Group B:** Alexander Ferguson School, Glendale School, Richmond School

### What are We Deciding?

By April 2018 the CBE will communicate plans for the sustainable use of learning space in schools impacted by the opening of Dr. Roberta Bondar School, Griffith Woods School and West Ridge School. Plans may be implemented for the 2018-19 school year or later.

### Who is the Decision-Maker?

The director of Planning and Transportation, director of Area 6 and director of Area 7 have joint responsibility for recommendations and decisions. Their focus is to make decisions that are best for the system as a whole. If a recommendation is made to consider school closure, then the chief superintendent decides whether to recommend a regulatory school closure process to the Board of Trustees.

### Planning Principles and What We Heard

When considering how to utilize learning space, we use the following planning principles. The principles are not intended to be a checklist but rather a guide to help make decisions for the common good of all students.

- minimize disruptions for students
- provide program continuity from kindergarten to Grade 12
- keep cohort groups of students together
- allow students to attend school as close to home as possible
- provide long term sustainability
- use space and resources effectively
- provide equitable access for all students to quality learning environments and choice of programs

In addition, stakeholders told us they would like the CBE to consider:

- Offer more alternative programs
- Offer classes for students with exceptional needs
- Before and after school care



## The Situation for Group A

- K-4 students from Cougar Ridge are designated to Rosscarrock School. Some Cougar Ridge students attend Wildwood School, the prior designated school for these students. West Springs School is closer to Cougar Ridge and next to West Ridge School, the designated regular program middle school for Cougar Ridge students.
- An online survey conducted in December 2017 - January 2018 indicated 86 per cent of respondents from Group A schools agree or somewhat agree with allowing K-4 students from Cougar Ridge to attend school closer to home.

## Proposed Plan for 2018-19 and Beyond

### Students from Cougar Ridge designated to West Springs School for kindergarten to Grade 4

- Current West Springs School students will remain at the school.
- West Springs School will have an enrolment cap of approximately 100 to 110 students per grade. This cap will enable the grade configuration to remain the same and provides the opportunity to have space for a library/learning commons and music room.
- For the 2018-19 school year:
  - Students from the West Springs community and current K-3 Cougar Ridge students at Rosscarrock and Wildwood schools will be designated to West Springs School.
  - K-4 Cougar Ridge students attending other CBE schools and non-CBE schools can register or transfer to West Springs School. If there are more students in this group than space available, a lottery will be held regardless of grade.
  - Current CBE students will have priority over non-CBE students for Grades 1-4.
- After the 2018-19 school year, if there are more kindergarten registrations than West Springs School can accommodate, all kindergarten registrations from Cougar Ridge will be subject to a lottery process for kindergarten.
- Wildwood School will be the designated overflow school for students not accepted into West Springs should a lottery occur.
- Grade 3 students from Cougar Ridge who wish to remain at Rosscarrock School for Grade 4 will receive busing for the 2018-19 school year without being charged a fee. Busing from Cougar Ridge to Wildwood School will end June 30, 2018 unless there is a need for overflow from West Springs School.

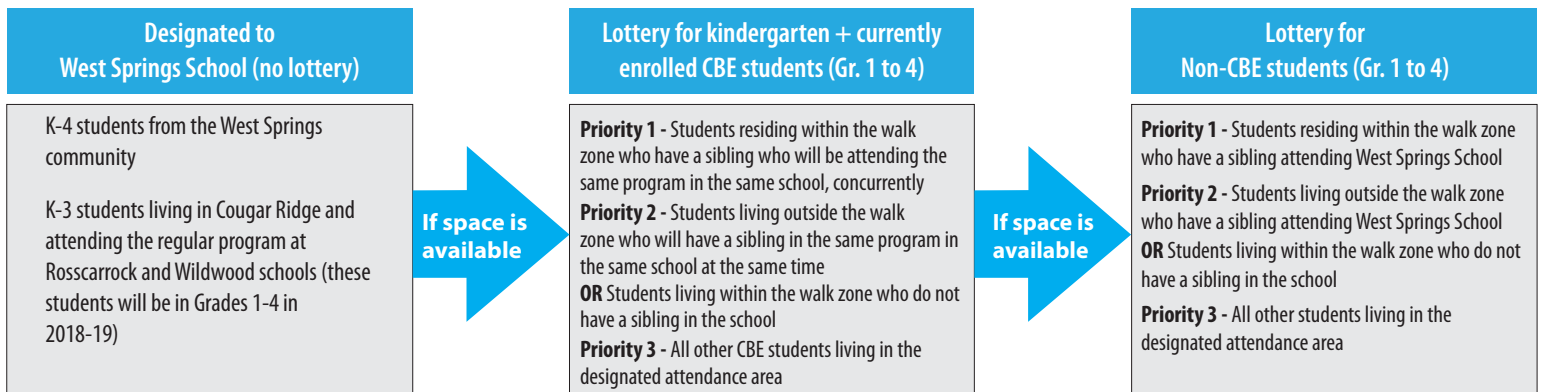

Key Factors and What We Heard	How the Scenario Responds
Allow students to attend school close to home	K-4 students from Cougar Ridge will be designated to West Springs School.
Lotteries create uncertainty	K-3 students West Springs, Wildwood and Rosscarrock schools will not be subject to a lottery. Projections indicate there will not be a need for a lottery. If there is a significant shift in enrolment patterns, a lottery will apply to Cougar Ridge students who do not currently attend Rosscarrock or Wildwood schools.
Minimize disruption to students	Grade 3 Cougar Ridge students can remain at Rosscarrock and will receive busing for the 2018-19 school year without being charged a fee. Cougar Ridge students in other grades may register as out-of-boundary students and families will be responsible for their own transportation to and from school.
Overcrowding is a concern	Enrolment at West Springs School will be capped.
Uncertainty for schools losing students	Maintaining Cougar Ridge students at Rosscarrock and Wildwood schools will not boost the population significantly and does not justify the increased travel time and distance for these students. Enrolment at these schools will be monitored and further discussions may be required.
Offer more alternative and/or GATE programs	Waitlists for these programs do not indicate an unmet need in the area. Limited funds are available to expand current programming.



## Registration and Lottery Process

### 2018-19 School Year



### Timeline

- **April 5** | Latest date the Area 6 and 7 impacted schools decision letters are sent to parents at Rosscarrock, West Springs and Wildwood schools
- **April 16** | Deadline for Cougar Ridge students at Rosscarrock and Wildwood schools to notify school of decision not to move to West Springs School
- **April 23** | Last day for Cougar Ridge students (not at Rosscarrock or Wildwood) to register or transfer to West Springs School
- **April 24** | West Springs School holds lottery, if needed
- **Lottery First Round**
  - **April 25 - May 8** | School will communicate initial acceptance within 10 business days after the lottery draw
  - **Latest May 23** | Parents confirmation of acceptance within 10 business days of notification of initial acceptance
- **Subsequent Lottery Rounds, as needed** | Same parameters as first round, until all spaces filled

### 2019-20 School Year and Beyond

- Students from the community of West Springs will attend West Springs School as their designated regular program school
- If there are more kindergarten registrations than West Springs School can accommodate, all kindergarten registrations from Cougar Ridge will be subject to a lottery process for kindergarten
